## FINANCIAL SUPPORT

There are many ways that you can provide financial support for A Bit Of Hope. We offer memberships in the form of Individual, Family, and Corporate. Membership privileges include a quarterly newsletter and an invitation to our annual celebration.

- Individual Membership: \$25.00
- Family Memberships: \$50.00
- Corporate Memberships: \$100.00

We also offer Rider Sponsorship Programs, Horse Sponsorship Programs, and Facility Sponsorship Programs.

Our Rider Sponsorship Program enables you to support one of our riders through tuition payments on an annual, semi-annual, quarterly, or monthly basis. The Rider Sponsorship fee is \$400.00 annually, \$200.00 semi-annually, \$100.00 quarterly, or \$35.00 monthly.

Our Horse Sponsorship Program is set up to help care for one horse on an annual basis. The average annual cost for one horse is approximately \$600.00. This includes feed, hay, vet care, vaccinations and farrier fees. The Horse Sponsorship Program fee is \$600.00 annually, \$300.00 semi-annually, \$150.00 quarterly, or \$50.00 monthly.

Our Facility Sponsorship Program is set up to enable sponsors to support the continuing education of the instructors and the continuing growth of the entire program. Our goal is for each of our instructors to become certified by the North American Handicapped Riders Association (NAHRA).
